Featuring candidates for: Irving City Council and IISD. Candidates for Carrollton - Farmers Branch and Coppell ISD Districts will be introduced.

MAY 2012 ELECTION

Irving voters will have choices in every race but one in the May 12 city and school board elections. All candidates named below in ballot order for their race .

The following candidates are running for Place 4, a single-member district: Phil Riddle, Fran Bonilla, and Joe Putnam, and Phil Riddle, with no incumbent in the race. Bonilla was previously a Council member, while Putnam has been both a Council member and a Mayor. Other City Council candidates include the following: newcomers Brad M. La Morgese and William "Bill" Mahoney are competing for Place 6, a single-member district, with **no incumbent** in the race. In the race for Place 8, an at-large district, there is no incumbent, but the two candidates Tom Spink and Richard H. Stopfer have both served as Council members for other districts. In the race for Irving Independent School District Board of Trustees. three people are competing in the race for Place 3,

vacated by the incumbent. Running are A.D. Jenkins, Alicia Fernandez-Mott, and Larry Stipes. Jenkins was previously a board member. In the Place 4 race, incumbent Valerie Jones is in a race with challengers Norma C. Gonzales and Dinesh Mali.

Irving voters will also choose trustees for the school boards of Carrollton-Farmers Branch and Coppell. In C-FB ISD, Randy Schackmann and John Mathews are competing for Place 3, and Richard Fleming is uncontested in his bid to retain Place 4. In Coppell ISD, Carrie Clark and Judy Barbo are competing for Place 6, which is being vacated by the incumbent while Charlie Biggurs and Tracy Fisher are competing for Place 7 with no incumbent in the race.

The last day to register to vote in the May 12 election is **April 12, 2012**. **Early voting** will be held from **April 30-May 8, 2012**, in the following locations: City Hall, 825 W. Irving Blvd., Irving Arts Center, 3333 N. MacArthur Blvd., and Valley Ranch Public Library, 401 Cimarron Trail.

Voters will need to bring their voter registration card with them when they go to vote. Additional picture identification will not be required. The law requiring an additional picture identification that was passed by the Texas legislature and signed by Governor Perry in 2011 has been held in abeyance by federal court.

VOTER SERVICE

Volunteers are **always** needed to help register voters at the United States Immigration and citizenship Center, so please take this opportunity to serve your League. It will be only a matter of passing out cards unless you are a deputy registrar who can provide assistance to the new voters.

DIRECTIONS - The United State Citizens Immigration Services (USCIS) center is located at 6500 Campus Circle Drive East, Irving, TX 75063.

The easiest route is to get to the Belt Line and 114 Intersection:

When approaching the intersection from the south, turn right onto the south 114 service road and stay to the right (towards Bush toll way). At Longhorn Drive, turn right, go 100 yards or so before making a left turn into the large USCIS parking lot. When approaching the intersection from the north, cross over 114 and turn left onto the south 114 service road. Stay to the right (towards Bush toll way). At Longhorn Drive, go 100

yards or so before making a left turn into the large USCIS parking lot.

After parking, enter the building through the front doors. You will have to go through security to gain entrance to the large assembly room were the ceremony takes place. Tell the security guards you are there to assist with voter registration of the new citizens.

If you would like to receive training to become a Deputy Registrar, here is your chance.




League Website up-date lwvirving.org

MEETINGS IN REVIEW January 23, 2012

State Highway 183

The League hosted a noon meeting focusing on the progress of construction of State Highway 183 on Monday, Jan. 23, 2012. City of Irving Director of Traffic and Transportation Dan Vedral presented information on the status of SH 183, including rightof-way acquisition, the design, as well as the timeline for completion. He added as a bonus to the audience an update on the DART Orange line. Mr Vedral noted that while the expansion of SH 183 is a State of Texas project, it is a team effort that includes our Federal, State and Local elected representatives, the Greater Irving/Las Colinas Chamber of Commerce, and the City. departments of the City have been involved in the development of the plans and the City has funded a portion of this huge project which will expand this thoroughfare from 10 lanes to 18 lanes which includes the access roads and four Managed Lanes. He noted that the City has insisted on above standard sound walls that are now under construction. They should be complete by October of this year. The City also works with the state in the acquisition of land parcels for the right-of-way although it is the state's responsibility for this part of the project. He stated that the current status of this acquisition is.....

- Total Parcels 342
- Total estimated cost \$260 M
- Acquired to date 221 (64%)
- Cost Paid to date \$160 M
- Remaining parcels 121 (36%)

Mr. Vedral further explained that the total cost of the project to the City can be broken down as follows:

- City 10% portion of ROW cost \$26.0M
- City water cost \$20.3M
- City sewer cost \$9.3M
- City total project share \$56.0M
- Less total paid to date (\$12.4M)
- Total city portion 43.6M
- Future Drainage Improvements \$15.0M
- Undergrounding \$14.0M
- IFCD #1 Twin Levee Issue \$20.0M

He advised that the state must receive from the Federal Government a "FONSI" (Finding of No Significant Impact) and that the state will conduct a hearing on February 21, 2012 on the project. (That

hearing has been conducted and over 120 residents attended. The State hopes to receive the FONSI in early April.)

"Learning English in our Public Schools – Part 2



In February, the League presented Part 2 in a series of meetings about "Learning English in Our Public Schools." The goal of this meeting was to present the side for the use of a form of "immersion" to integrate non- English speaking students into our school curriculum in lieu of the standard bilingual programs used in the public school systems. The speaker was James Golsan, an Education Policy Analyst for the Texas Public Policy Foundation located in Austin Texas. This foundation commissioned a study titled "Does Bilingual Education Work: The Case of Texas" by Christine Rossell in 2009. (This study can be found on our web site.) Mr. Golsan introduced the subject by noting that funding for education in Texas is the main issue as it is the second largest portion of the state's budget after Medicare. Bi-lingual education programs are costly; although, that is not the primary reason that immersion is favored by many as the best way to educate our students. He noted that revenue generators for education as well as how it is distributed to the individual school districts will be hot topics when the state legislative session convenes in 2013.

While Mr. Golsan did not review the study in detail, he did state that the foundation advocates sheltered immersion as the default model as early as possible and this will give more choices to the parents of English Language Learners. He also mentioned the move from the TAKS testing to the STAAR testing and noted that we have yet to see the impact of this testing on our students. He urged open discussion of this issue in the community, and

there was a lively discussion following his talk. Many educators were present that told of their experiences not only in the classroom, but their personal experiences as first generation Americans. They were advocates for some form of immersion as the best way for students to gain language skills to carry them through to high school graduation. Also present were educators that spoke in favor of bilingual education.

To present in this brief article any of the positions would be difficult and unless it was done as a straight quote, there would be a possibility of misrepresenting the message. However, the fifty plus people that attended heard enough facts and personal experiences to give them much to think about as we all continue to explore this subject that is so important in our world of education today.

State of the Vote Fundraising Event

A fundraiser to benefit the **League of Women Voters of Irving** included an informative discussion on 2012 elections by three political science professors. After lunch was served at **Las Colinas Country Club**, **Collette Vallot**, community relations senior manager at TXU, introduced the professors and moderated the discussion.

The professors were: **Cal Jillson**, chair of the Political Science Department at **Southern Methodist University** and author of a new book



called Lone Star Tarnished; James Riddlesperger,, chair of the political science department at Texas Christian University; and Allan Saxe, Associate Professor at the University of Texas at Arlington's Political Science Department. They talked about the influence of Super PACs, redistricting in Texas, voting demographics, presidential power and the 2012 election. All three predicted Mitt will be the

Republican nominee and his first running mate candidates may be Marco Rubio of Florida, Bob McDonald of Virginia or Susanna Martinez of New Mexico. They also predicted Obama should win in November.

In talking about social media, Riddlesperger said his students don't read newspapers--the Internet is their source of news.

Guests asked questions about women's health care issues, and also about Obamacare, which Riddlesperger said is a complex program. But all three advocated an informed democracy where citizens learn more and get engaged. And especially at the local level, they said, where an impact can be made.


